WEDDING DIARIES AND BRIDE DIARIES CONTRACT AGREEMENT OVERVIEW: This Agreement expresses the full and complete agreement between the named parties and WEDDING DIARIES AND BRIDE DIARIES (Hereafter referred to as WEDDING DIARIES AND BRIDE DIARIES) regarding the subject matter hereof. It supersedes all prior agreements. The only way to add or change this agreement is to do so in writing, signed by all parties.

COOPERATION: Unless agreed otherwise, WEDDING DIARIES AND BRIDE DIARIES will be the only photographer(s) and/or content creator(s) at the event. Parties agree that good faith, cooperation and communication between them is important in obtaining a good result. WEDDING DIARIES AND BRIDE DIARIES recommends that the CLIENT identifies to the photographer(s) and content creator(s) important individuals and moments during the event and during associated portraits, if they wish to have them photographed or videoed. WEDDING DIARIES AND BRIDE DIARIES will not be held accountable for not photographing and capturing content of desired guests and specific moments if there is no one to assist in identifying and gathering people for photographs/videos. WEDDING DIARIES AND BRIDE DIARIES is not responsible if key individuals fail to appear or cooperate during photography, or for missed images due to details not revealed to WEDDING DIARIES AND BRIDE DIARIES or beyond the photographer(s) and content creator(s) control. CLIENT will provide WEDDING DIARIES/BRIDE DIARIES with a supplier meal. BRIDE DIARIES is vegetarian and cows milk free, so a suitable meal will be supplied to cater to dietary requirements.

HOUSE RULES: CLIENT agrees and understands that the photographer(s) and content creator(s) are limited by the guidelines of the ceremony official or reception site/venue management and CLIENT agrees to accept the results that may occur from said guidelines. Negotiation with the officials for moderation of guidelines is solely the CLIENTs responsibility. WEDDING DIARIES AND BRIDE DIARIES will however offer technical recommendations concerning such guidelines.

IMAGES AND COPYRIGHTS: Photographs/images produced by WEDDING DIARIES are protected by International Copyright Law (all rights reserved). Upon final payment by CLIENT, CLIENT is granted limited license to use and display resulting images for personal use, including online non commercial photo sharing. Said images may not be altered or reproduced in any manner without prior written permission of WEDDING DIARIES. This excepting CLIENTS who received a USB drive with printing rights, who may make prints for personal use but may not copy, resell or distribute the files in any manner. The CLIENT must obtain written permission from, and compensate WEDDING DIARIES prior to the CLIENT, its associates, friends or relatives publishing or selling the photographs.

MODEL RELEASE: The CLIENT hereby grants to WEDDING DIARIES AND BRIDE DIARIES and successors, heirs, executors, administrators, trustees, representatives and agents, the irrevocable and unrestricted right to use and publish photographs and videos of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising or any other purpose and in any manner or medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases WEDDING DIARIES AND BRIDE DIARIES and all associates, representatives and assigns from any and all claims, actions, demands, suits, liabilities, damages, expenses, and obligations of any kind arising from, or related in any matter to WEDDING DIARIES/BRIDE DIARIES use of said images.

DEPOSIT & PAYMENT SCHEDULE: CLIENT will pay a non refundable deposit of £150 to secure the date. A second instalment of 50% of the final amount is to be paid 3 months prior to the event. The final instalment is to be paid 1 month before the event. In cases where event requires travel/accommodation costs more than the sum of £150 to be paid up front, this will count as the clients deposit. ALL TRAVEL AND ACCOMMODATION COSTS MUST BE PAID IN FULL TO SECURE THE DATE. This is so WEDDING DIARIES AND/OR BRIDE DIARIES can secure accommodation and travel on the day of the booking or as soon as possible. In cases where the CLIENT books WEDDING DIARIES/BRIDE DIARIES under 3 months before their wedding date, a deposit of £150 is required to secure the date, then the full amount is due 1 month before the date of the wedding.

LIMIT OF LIABILITY: In the unlikely event that the photographer(s) are injured, become too ill or has an emergency that prevents them from photographing an/or capturing content at the event, WEDDING DIARIES AND BRIDE DIARIES will make every effort to secure a replacement photographer or content creator. If a suitable replacement is not found, CLIENT agrees that responsibility and liability of WEDDING DIARIES AND BRIDE DIARIES to the CLIENT is limited to the return of all payments received for the event. If your venue is more than 3 hours away from the home of WEDDING DIARIES/BRIDE DIARIES and you require early morning bridal prep coverage, accommodation the night before the wedding is highly recommended. This is to ensure WEDDING DIARIES/BRIDE DIARIES arrive on time without any unforeseen delays. In the unlikely case where there is no possible way to get around unforeseen train strikes/road traffic on the morning of the event, WEDDING DIARIES AND BRIDE DIARIES will make every effort to secure a replacement photographer or content creator. If a suitable replacement is not found, CLIENT agrees that responsibility and liability of WEDDING DIARIES AND BRIDE DIARIES to the CLIENT is limited to the return of all payments received for the event. WEDDING DIARIES AND BRIDE DIARIES takes the utmost care with respect to exposure, storage and processing the photographs/videos/images, but cannot and does not, guarantee that photographs/images of the event will not be lost, stolen, or destroyed for reasons beyond WEDDING DIARIES AND BRIDE DIARIES control. CLIENT agrees that WEDDING DIARIES AND BRIDE DIARIES full and complete responsibility and liability is limited to the return of payments received for the event. CLIENT further agrees that the limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the estimated percentage of the total number of original images.

COMPLETION SCHEDULE: Images are expected to be prepared for proofing within 1 weeks of the event

date. USB creation is expected within 4-6 weeks. Content Creation is delivered within 24 hours of event. Edited videos are delivered within 24-72 hours of event.

The final total is %total_invoiced%. Once a £150 deposit is paid, the remaining amount is split into 2 final payments. One is due 3 months before the big day, the final is due 1 month before the big day. Client can pay this off in full ahead of these timings if they wish.
